**Item 2, specifically the acquisition of a total of three million four hundred ten thousand (3,410,000) ordinary shares of 7-Eleven Malaysia Holdings Berhad ("SEM"), a company domiciled in Malaysia and listed on Bursa Malaysia Securities Berhad for a total cash consideration of Malaysian Ringgit four million six hundred forty six thousand eight hundred seventy nine (RM4,646,879.00).**

### Item 1. Changes in Control of Issuer

No change in control in the Issuer will occur or is foreseen by the Issuer's purchase of a total of three million four hundred ten thousand (3,410,000) ordinary shares of SEM in the open market of Bursa Malaysia Securities Berhad.

### Item 9. Others

The Issuer purchased a total of three million four hundred ten thousand (3,410,000) SEM ordinary shares commencing 7 September 2018 to 19 December 2018 for a total cash consideration of Malaysian Ringgit four million six hundred forty six thousand eight hundred seventy nine (RM 4,646,879.00) at an average purchase price of RM1.36 per SEM share converted to Philippine Pesos Fifty Eight Million Eight Hundred Seventy Five Thousand Nine Hundred Fifty Seven (Php58,875,957.00) or at Php17.27 per SEM share. The total shares acquired represents point thirty percent (0.30%) equity interest in SEM. Following the acquisition, the Issuer now holds a total of twenty one million four hundred ten thousand (21,410,000) ordinary shares representing one point ninety percent (1.90%) equity interest in SEM. The SEM shares were acquired free from all encumbrances and the acquisition was funded from the Issuer's internal funds.
