Item 2, specifically the sale of a total of nine million eight hundred forty three thousand (9,843,000) ordinary shares of 7-Eleven Malaysia Holdings Berhad ("SEM"), a company domiciled in Malaysia and listed on Bursa Malaysia Securities Berhad for a total cash consideration of Malaysian Ringgit thirteen million seven hundred eighty thousand and two hundred (RM13,780,200.00) to Berjaya Land Berhad through a direct business transaction on 2 September 2020.

Item 1. Changes in Control of Issuer

No change in control in the Issuer will occur or is foreseen by the Issuer's disposal of a total of nine million eight hundred forty three thousand (9,843,000) SEM shares for a total cash consideration of Malaysian Ringgit thirteen million seven hundred eighty thousand and two hundred (RM13,780,200.00) on 2 September 2020.

Item 9. Others

The Issuer had on 2 September 2020 disposed a total of nine million eight hundred forty three thousand (9,843,000) SEM shares for a total cash consideration of Malaysian Ringgit thirteen million seven hundred eighty thousand and two hundred (RM13,780,200.00) or RM1.40 per SEM share converted to Philippine Pesos at one hundred sixty one million ninety thousand five hundred thirty eight (Php161,090,538.00) or at Php16.37 per SEM share through a direct business transaction.

Following the disposal, the Issuer now holds a total of 6,856,975 SEM shares representing 0.60% equity interest in SEM.

The assumed rate is RM1.00 = Php 11.69
