Item 2, specifically the sale of a total of fifteen million (15,000,000) ordinary shares of REDtone Digital Berhad (formerly known as REDtone International Berhad) ("REDtone"), a company listed on Bursa Malaysia Securities Berhad through the open market from 26 October 2021 to 28 October 2021.

Item 1. Changes in Control of Issuer

No change in control in the Issuer will occur or is foreseen by the Issuer's disposal of a total of fifteen million (15,000,000) REDtone shares for a total cash consideration of Malaysian Ringgit nine million six hundred thousand and five (RM9,600,005.00) on 26, 27 and 28 October 2021.

Item 9. Others

The Issuer disposed a total of fifteen million (15,000,000) REDtone shares for a total cash consideration of Malaysian Ringgit nine million six hundred thousand and five (RM9,600,005.00) converted to Philippine Pesos at one hundred seventeen million three hundred eighty six thousand nine hundred forty one and fourteen centavos (Php 117,386,941.14) through the Bursa Malaysia Securities Berhad open market, broken down as follows:

Prior to the disposals, the Issuer had forty million four hundred thirty two thousand (40,432,000) common shares of REDtone representing 5.23% equity interest in REDtone.

Following the disposals, the Issuer has ceased to be a substantial shareholder and now holds a total of twenty five million four hundred thirty two thousand (25,432,000) REDtone shares representing 3.29% equity interest in REDtone.
