Item 2, specifically the sale of a total of three million two hundred thousand (3,200,000) ordinary shares of Berjaya Food Berhad ("BFood"), a company listed on Bursa Malaysia Securities Berhad through the Malaysian Stock Exchange on 17 January 2022.

Item 1. Changes in Control of Issuer

No change in control in the Issuer will occur or is foreseen by the Issuer's disposal of three million two hundred thousand (3,200,000) BFood shares for a total cash consideration of Malaysian Ringgit six million five hundred sixty thousand (RM6,560,000.00) on 17 January 2022.

Item 9. Others

The Issuer disposed or sold three million two hundred thousand (3,200,000) BFood shares for a total cash consideration of Malaysian Ringgit six million five hundred sixty thousand (RM6,560,000.00) converted to Philippine Pesos at eighty million three hundred sixty six thousand five hundred sixty (Php80,366,560.00) through the Malaysian Stock Exchange.

Prior to the disposal, the Issuer had a total of three million two hundred thousand BFood shares representing 0.88% equity interest in BFood.

Following the disposal, the Issuer ceased to be a shareholder of BFood.

The exchange rate is RM1.00 = Php 12.251
