

It is 45mins drive from NAIA with few competitors within 500meters radius - St Giles, City Garden, Red Planet and local budget hotels including Airbnb facilities.



FEC Background

Floridablanca Enviro Corporation ("FEC") was incorporated on April 7, 2017 and is registered to engage in the business of protecting and cleaning the environment. At present, FEC has not yet started commercial operation and still in construction stage.

Floridablanca Enviro Park Project is to develop an engineered sanitary landfill under the concept of Design-Build-Operate-Own and Invest.

The projects provides designed **waste disposal capacity of 9.5million tonnes** with an anticipated life span of 25 years. The Project will be divided in 5 phases. As of today, Phase I is on-going construction.

This will cater mainly to Province of Pampangga and other nearby Cities.

BERJAYA Philippines Rising To The Challenge

As COVID-19 pandemic sweeps across the world, the role of the private sector is encouraging even if their businesses have to step back during the crisis. PANGARAP ELEMENTARY SCHOOL in Caloocan City is a public elementary school of about 3,000 pupils that is located 24 kilometers north of Manila. "Our school needs electric power and water supply. The sanitary landfill facility designed to receive 10 million cubic metres wastes is nested on a 91-hectare property in Brgy. Pabanlag, Floridablanca. With the concept of Design-Build-Operate-Own and Invest (DBOOI), the facility is intended to cater and to provide the Province of Pampanga a long-term solution for waste disposal and will be fully operational by 2023.
